**Genesis** With the blessings, support and encouragement given by His grace Rt. Rev. Dr. Geevarghese Mar Theodosius Episcopa (Diocesan Bishop, Thirvananthapuram-Kollam Diocese of the Mar Thoma Church) the society “Grama Jyothi National Institute For The Differently Abled” got registered on Wednesday, 3<sup>rd</sup> November, 2004. The Society started its functioning with a donation from Mr.Thomas Mammen and Mrs. Anamika Thomas in memory of their late parents (Mr. Ajoy Kumar Ghose, Ms. Sushila Rudra & Mr. and Mrs. C.C.Mammen Charivukalayil Kumbanad). All expenditures initially were met from this amount. This society has got registration u/s 12A (a) of the Income Tax Act 1961 with effect from 16-12-2005. At present the major activity of the society is managing the Grama Jyothi Special School for the benefit of the Differently Abled Children (Mentally Challenged) for which our society has obtained necessary registration from the Directorate of Public Instruction (Education Department).

### ANNUAL GENERAL BODY MEETING

The 3<sup>rd</sup> Annual General Body meeting of the Grama Jyothi Society was held at 6.00 pm on Tuesday, 25<sup>th</sup> September, 2007 at the Grama Jyothi Special School Nalanchira. Rev. T. J. Abraham, President of the society presided the meeting. Annual Report, Audited Accounts for the year ended 31<sup>st</sup> March, 2007 and the Budget for 2008-09 was approved and passed unanimously.

### **Managing Committee Meetings**

During the year 2007-2008 the Managing Committee met six times and took necessary steps for the growth and development of the Grama Jyothi Special School.

**THE GRAMA JYOTHI SPECIAL SCHOOL** is for Differently Abled kids between the ages of 5 to 18 who have a low I.Q. The school provides a structured environment where individual attention and guidance is given at all times. The first academic session of the Grama Jyothi Special School started on 2<sup>nd</sup> June, 2005 with 2 special kids with multiple disabilities. At present the strength is 20. However due to the apathy and ignorance of parents and ill health of students, their average attendance during the year was 10. This school provides free coaching and free transportation.

During the year, on the pay roll we had the following staff.

We are grateful to God almighty for providing us with a team of dedicated staff. We appreciate their sincerity and commitment because of which we have been able to maintain the high standard of the school.

## **PROGRAMMES & EVENTS**

### **P. T. A. MEETINGS**

P.T.A. meetings were regularly conducted during the academic year 2007-2008. During these sessions there was a healthy interaction between the parents, teachers and management so as to enable everyone to get the best positive growth and development for each student. Counseling and guidance was also provided to the parents.

### **ONAM CELEBRATIONS**

We are grateful to the Principal, Mrs. Mary Mathew, the Primary section and the members of the social service club of St. Thomas Higher Secondary School who under the leadership of the Headmistress Mrs. Lenu Thomas and teachers visited our school on 13-08-07. Cultural items such as OnamPattu, Pulikali, Thiruvathira etc were put up by them which made the Grama Jyothi students ecstatic. It was sheer joy to see their radiant smiles. Our school students were amused to see 'Mahabali' in his royal attire with the 'Olakkuda' (umbrella made of palm leaf). They were also thrilled with the 'goodies' received.

Our School celebrated Onam on 24-08-07. The students helped by the teachers had fun making the 'pookalam' (floral carpet) and decorating the school. 'Payasm' was prepared at school and distributed to all.

### **PICNIC**

On 7.9.07 the management, staff, parents and students went for a picnic to Akkulam children's park. It was a first time experience for many a parent and child. Everyone enjoyed climbing, sliding, hanging, swinging, rocking etc. Many of the students in the excitement of the moment unconsciously responded with unexpected improved responses and actions, which we all would never have dreamt of, to see in them, in the daily school settings.

### **COUNSELLING**

On 30.10.07 the management arranged for **Rev Chacko P. George** to come and take a session for the parents and teachers. Many parents utilized the opportunity to clear their doubts and problems. It was a fruitful interactive session.

During the month of December **Dr. Elizabeth** and **Smt Neena**, Psychologist, spent a day at school. They observed the students and interacted with the parents giving them valuable advice and suggestions.

## **X' MAS CARDS**

With the support and encouragement received from various schools and the experience and confidence which we acquired through the previous year's X'mas card sale, the management this time decided to print ten thousand X'mas cards. 10 different pictures made by a few of our students, with the help of the staff were selected for printing. ## SCHOOL BUS

By the Grace of God we were able to purchase a School Bus (Traveler 17+D ) for a total cost of Rs. 6,53,000/- by availing a term loan of Rs 5,50,000/- (Rupees Five Lakh Fifty Thousand) from the Canara Bank on 4<sup>th</sup> August, 2006. This amount was to be repaid within a period of **72 months**. However, God Almighty, in His grace and mercy, used many as His instruments and abundantly blessed us to **clear the loan liability in full within a short span of 18 months**. We have been witnessing over and over again the unseen hand of God Almighty working amidst us. We praise and thank God for making the impossible, possible and turning our dreams into realities.

## **SOCIAL SERVICE**

For the first time, the Society extended its services to few of the aged friends residing at Eventide who had been longing for an outing. We are happy to have been able to fulfill their desire by providing transportation and support by taking them to Church and Veli park for a picnic.

## **REGISTRATION UNDER FCRA – A MIRACLE.**

Amidst great discouragement we applied for registration under the Foreign Contribution (Regulation) Act on 11<sup>th</sup> January 2008. We faced hurdles at each stage, and never in our wildest dreams did we expect to get the registration so fast. All we can do, is once again, give praise and thanks and proclaim that our living God is Almighty, wonderful and faithful in answering our prayers. We can boldly say “if **God is for us who can be against us**”. Exactly within six months i.e. on 11<sup>th</sup> July 2008, our society has got registration under Foreign Contribution (Regulation) Act.

## **OUR VISION AND IMMEDIATE NEEDS**

God’s faithfulness and His miracles in the past have emboldened us to attempt greater things for Christ in the future. The rehabilitation of the mentally challenged is a burning need of the community. After the parent’s lifetime, the differently abled become a liability for the community. Thus the rehabilitation of the Mentally Challenged, Differently abled children and the aged is the need of the hour. For the past 4 years we have been able to reach out to only a ‘drop’ from out of the ‘ocean’ of the differently abled people, in a rented building. In order to extend our scope of service on a permanent basis to a larger number of people, our urgent requirement is to accommodate the school in a spacious campus with full-fledged hostel facilities for girls / ladies and boys/gents.

Old age is the second childhood. To utilize their wisdom and experience for the benefit of the community and to keep them occupied, we plan to involve them with the activities of the school, so that they do not drown in loneliness and self pity. For this we plan to establish a home for the senior citizens who have been left alone, to face the battles of the life at this late age, by their children, who have left them and gone in search of greener pastures.

In order to implement our vision into a reality, we require 15 to 20 hectares of land and buildings for the School, Rehabilitation Centre, Hostels, and Home for Senior Citizen etc. At present the land value in the interior village area in Thiruvananthapuram district is about Rs. 60 to 65 lakh per hectare. Hence our immediate need for the project (including land and buildings) is approximately Rs. 8 crore (\$2 million). The number of differently abled children and senior citizens who are in need of special attention are increasing manifold every year. We feel that it is our duty in Christ, to take up the yoke of responsibility to do something for the benefit of the neglected, downtrodden and the needy. ‘Grama Jyothi National Institute For The Differently Abled’ was formed with this firm conviction – i.e. doing His service for the benefit of the underprivileged.

We request our relatives, friends and well wishers, social organizations, institutions and agencies all over the world to join us to make this dream a reality, by contributing magnanimously with

their time, effort and finances. Keeping in mind God's promise "**HAPPY ARE THOSE WHO ARE CONCERNED FOR THE POOR; AND WHEN YOU GIVE TO THE POOR, IT IS LIKE LENDING TO THE LORD AND THE LORD WILL PAY YOU BACK**" (Psalms 41:1, Proverbs 19: 17).
